DIRECTIONS TO THE TRIAL OF WESSEX:-

From the South Leave the M5 at junction 25. Take the A358 heading to A37/Weymouth/Langport/Chard/Ilminster/Yeovil. After 2.4 miles, slight left on A378. Turn left to stay on A378. Continue for 9.3 miles. Turn left at A378 North Steet. Continue on A372 Somerton Road. Continue on B3153. After 3.4 miles turn right onto Gasson's Lane. The sport club is 0.1 mile on the left. From the North leave M5 at Junction 23 and follow A39 until Street, then Take B3151. From the east Take A303 to Podimor roundabout then A372 direction Somerton and Langport. After approx one mile take B3151 to Somerton.
